### **Information We Collect**

The Talent Pool (UK) Ltd processes your personal information to meet our legal, statutory and contractual obligations and to provide you with our products and services. We will never collect any unnecessary personal data from you and do not process your information in any way, other than as specified in this notice.

### The personal data that we collect from is: -

- Special Category Data (i.e. health/medical information, etc)

### We collect this information in the below ways: -

- Via one to one personal consultations with employees of client organisations
- Via delegates completing questionnaires
- Existing clients, potential clients and delegates supplying us with their contact details via various methods such as email.

## How We Use Your Personal Data (Legal Basis for Processing)

The Talent Pool (UK) Ltd takes your privacy very seriously and will never disclose, share or sell your data without your consent; unless required to do so by law. We only retain your data for as long as is necessary and for the purpose(s) specified in this notice.



#### The purposes and reasons for processing your personal data are detailed below: -

- **Example:** We collect your personal data in the performance of a contract or to provide a service that can be sent out to your preferred address
- **Example:** We collect and store your personal data as part of our legal obligation for business accounting and tax purposes

#### **Sharing and Disclosing Your Personal Information**

We do not share or disclose any of your personal information without your consent, other than for the purposes specified in this notice or where there is a legal requirement. The Talent Pool (UK) Ltd uses employees and associates to provide the below services and business functions; however, all processors acting on our behalf only process your data in accordance with instructions from us and comply fully with this privacy notice, the data protection laws and any other appropriate confidentiality and security measures.

The following organisations are used to process Psychometric profiling tools on behalf of the Talent Pool: Thomas International, Oxford Psychologists Press, The Good Boss Company, Aspirin Business Solutions and Talent Dynamics.



We use MJP Bookkeeping to do our bookkeeping and tax returns and they act in the capacity of a processor on our behalf. The only information we provide them with is your name, address and order details to meet business and legal requirements.

### **Safeguarding Measures**

The Talent Pool (UK) Ltd takes your privacy seriously and takes every reasonable measure and precaution to protect and secure your personal data. We work hard to protect you and your information from unauthorised access, alteration, disclosure or destruction and have several layers of security measures in place.

### Transfers Outside the EU (if applicable)

Personal data in the European Union is protected by the General Data Protection Regulation (GDPR) but some other countries may not necessarily have the same high standard of protection for your personal data. The Talent Pool does not transfer or store any personal data outside the EU.

### **Consequences of Not Providing Your Data** [if relying on statutory/contractual requirement basis]

You are not obligated to provide your personal information to The Talent Pool (UK) Ltd, however, as this information is required for us to provide you with our services, we will not be able to offer some/all our services without it.

### How Long We Keep Your Data

### **Special Categories Data**
